NC Medicaid Expansion

- NC Medicaid Expansion was not passed during the previous NC General Assembly session
- A legislative Committee w/ members from both chambers will be created to will hear a Medicaid Modernization Plan to be developed by NC DHHS
- If General Assembly accepts the plan proposed by NCDHHS, then will vote on it by Dec. 15
- Any plan proposed is likely to include Medicaid Expansion

Medicaid Unwinding Updates

- As part of the COVID-19 Federal Public Health Emergency individuals with Medicaid/CHIP cannot be disenrolled while PHE is active
- PHE was last extended for 90 days on April 16, 2022
- PHE is unlikely to end on July 15 as required 60 day notice
- Concern that once PHE ends, will be many people disenrolled from Medicaid who need to transition to other coverage, including Marketplace

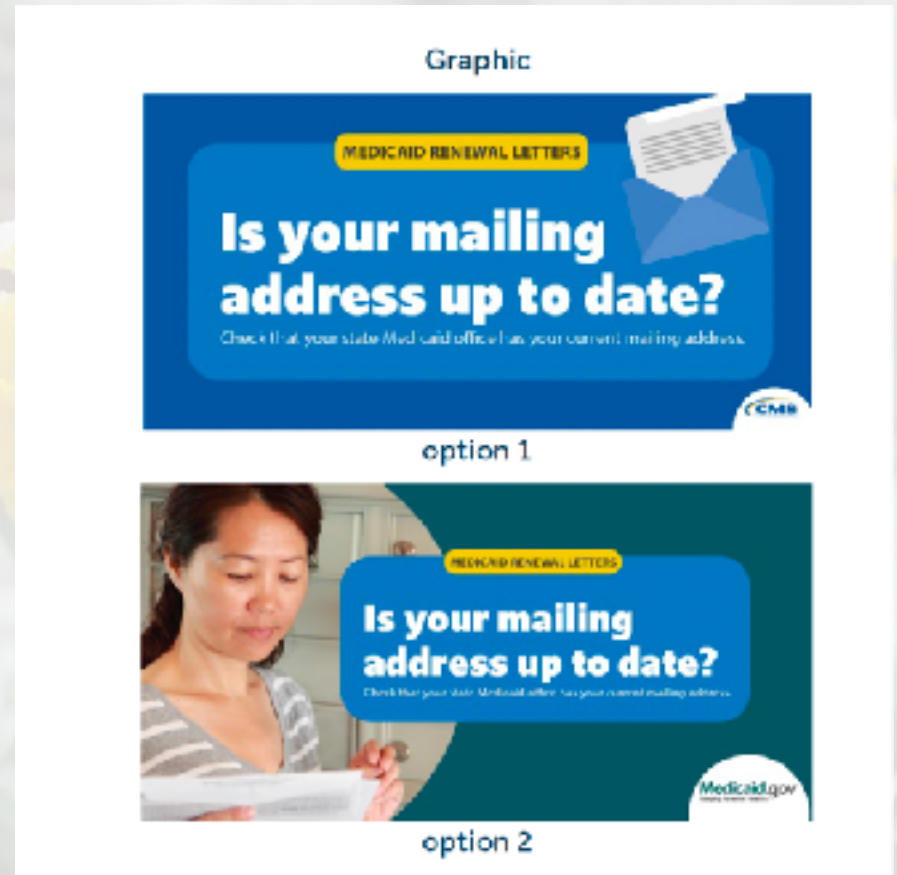
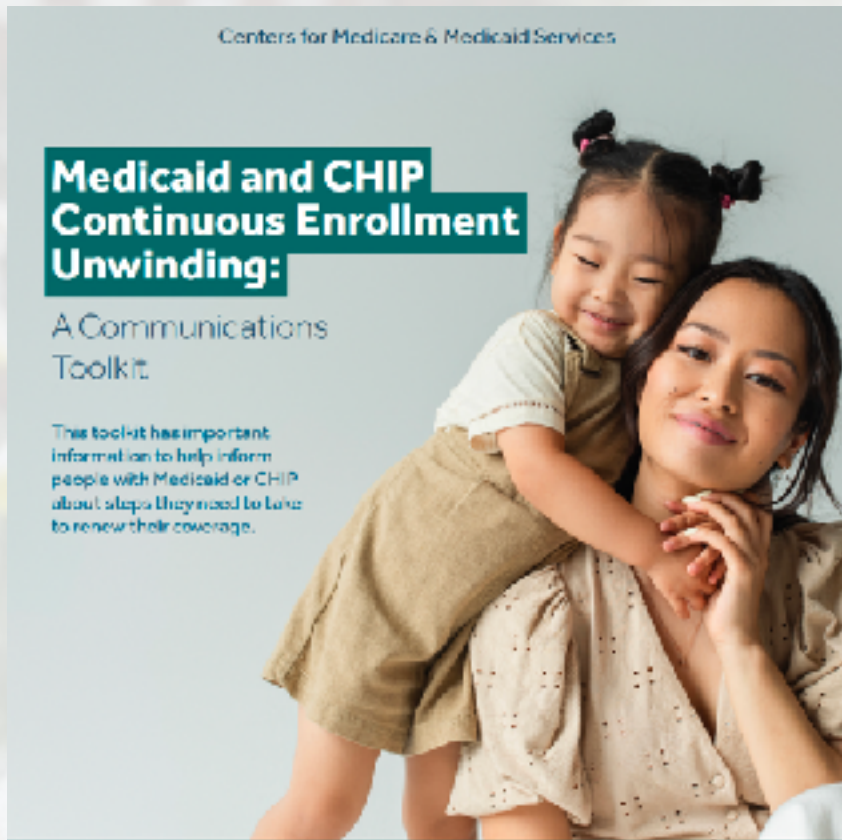
