# Medicaid Unwinding Updates

- As part of the COVID-19 Federal Public Health Emergency individuals with Medicaid/CHIP cannot be disenrolled while PHE is active
- PHE was last extended for 90 days on July 15, 2022
- PHE is unlikely to end on Oct 15 as required 60 day notice
- Concern that once PHE ends, will be many people disenrolled from Medicaid who need to transition to other coverage, including Marketplace
