- All NC Friday Health Plans through the FFM will end Sept. 1, 2023
- An SEP is available for FFM NC Friday Health Plan enrollees Jul. 2 Oct. 30,
 2023
- Consumers MUST enroll in a new plan through the FFM by Aug. 31, 2023 in order to avoid a gap in coverage


